



### **Admission Process**

- Admissions to BDS course in AGDC & IGM Hospital will mandatorily take place through the national level NEET exam conducted across the country by order of Government of India/Government of Tripura/ Dental Council of India/ National Dental Commission.
- In order to be eligible for the course, the student must attain a minimum of 50% in the 10+2 qualifying examination.
- The candidate should pass individually in English, Physics, Chemistry and Biology and obtained minimum 50% (fifty percent) marks taken together in Physics, Chemistry and Biology in qualifying examination. In respect of candidates belonging to Scheduled Castes, Scheduled Tribes or other backward Classes, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination may be 40% (forty percent) instead of 50% (fifty percent)
- Candidates must have completed 17 years at the time of admission or before December
   31 of the year of admission.
- The candidates are allowed to enter the admission process of the college only if they meet the eligibility criteria.
- Once the students clear the cut-off set for the exam, they can proceed with the counseling sessions for admission to the college.

- (xv) Character Certificate from the institutions where from he/she has passed his /her qualifying examination which would mention the status of his / her behavioural pattern especially in terms as to whether he/she has displayed persistent violent or aggressive behaviour or any desire to harm others.

#### Scheme of Examination:

- The examination shall be open to a candidate who satisfies the requirements of attendance, work done completion, progress and other rules laid down by the University.
- Any student who does not clear the BDS Course in all the subjects within a period of 9
  years, including one-year Compulsory Rotatory paid Internship from the date of
  admission shall be discharged from the course.

### **General Rules**

- ➤ College Timings: 9.00 AM To 04.30 PM,
- Lunch Break: 01.00 PM To 2.00 PM
- Saturday: 9.00 AM To 04.30 PM (2<sup>nd</sup> and 4<sup>th</sup> Saturdays are closed according to Government regulations)
- **1. ATTENDANCE -** Regularity in attending lectures and practical sessions is compulsory. Students must have attended a minimum of 80% of each theory and practical in each term to be eligible to appear for the annual exam at the end of each year.
- **2. DISCIPLINE** Students should be polite and respectful with staff, patients, colleagues, and junior colleagues. Indiscipline shall be dealt with strictly. Proper college uniforms with aprons and nameplates should always be worn by students. Ragging, in any form, is not permitted and severe disciplinary action would be taken in case any student is found to indulge in ragging.
- **3. INTERNAL EVALUATION** Every student is expected to take the internal test at the end of each term and preliminary exams as scheduled. The score for each test /exam will constitute total internal examination marks in theory and practical. Marks obtained in these exams will be later considered while computing internal evaluation marks for both theory and practical.
- 4. **PAYMENT OF FEES AND DUES** College tuition fees and other expenditures and all other dues should be paid as per schedule.
- **5. HOSTEL FACILITIES** Hostel facilities are provided to UG students.
- **6. EXTRACURRICULAR ACTIVITIES** These activities shall be encouraged by the institute and students shall be motivated to participate in them by the college, however, students should not remain absent from lectures/practical for the purpose.

**7. STUDENTS/TEACHER RELATIONSHIP** - All students are expected to discuss any problems with the staff and to communicate freely. However, respect from students is expected for all teaching and non-teaching staff members

#### 8. ANTI-RAGGING COMMITTEE -

The committee has been formed by the institute to prevent any untoward event due to ragging/gender harassment on the campus.

#### 9. INSTITUTE PROPERTIES

Students must handle with great care the laboratory/instruments/devices etc. while at work and in no way indulge in destroying, mutilating, and writing on walls, damage any property of the Institute including furniture, books, equipment, and apparatus. In case of any losses/damage caused, the same will be made good by the individual.

- 10. If the Institute finds any suppression of any material, fact, or information while seeking admission, his/her admission may be cancelled, or any result of the examination shall be withheld without assigning any reason.
- 11. Circulating unauthorized notices is strictly prohibited.
- 12. Students are also prohibited from becoming members of outside societies or political organizations except Dental & Medical Organizations.
- 13. No meeting of the students other than those organized under the ageis of various recognized student activities shall be called without any prior permission in writing from the Head of the Institute.

#### Students are prohibited from the following acts:

- 1. Demonstration in any form including procession and meeting.
- 2. Strike or hunger strike.
- 3. Boycotting of an Institute program or activities.
- 4. Abusing
- 5. Recourse of violence, assault, intimidation, and rioting

### Library

#### **INSTITUTE LIBRARY**

- 1. Central Library is available for all students in the institute campus.
- 2. More than 500 standard text books are available in the Library.
- 3. E-Library facility is available for the easy access of the students.
- 4. Availability of all the volumes of International and National journals are there.

- 6. Students must strictly follow the library rules for borrowing books and shall take proper care while using the books.

- 9. Personal belongings/ items while entering the library must be deposited at the entrance gate of the library. Aprons or lab coats must be deposited at the entrance gate of the library.

### Hostel

#### **HOSTEL**

- 1. Hostel facility is available for both boys and girls
- 2. The newcomers and students will report to the Student Coordinators, Hostel in charge &Warden to seek permission for allotment of room or seat in the hostel after clearing his/her dues.
- 3. While occupying the room, he/she must check the items of the room, fixtures, and fittings including electric, furniture, and other articles placed therein, and sign the inventory list for correctness and having taken over.
- 4. No furniture/item of the room shall be shifted or removed nor any electrical appliance like TV, VCR & VCP to be used in the room.
- 5. Any kind of electrical appliance is not allowed without proper permission. Ensure the lights/ fan etc. are switched on only when needed.
- 6. Students must be cautious about the safety and security of their personal belongings. Students are not allowed to keep private servants.
- 7. Guests are not permitted to stay overnight in the room of the students, they should seek permission to accommodate them in the guest room.
- 8. Students are allowed to occupy the rooms allotted to them within 3 days before commencement of their academic session. They should hand over the charge of their room before proceeding on the summer vacation and as & when asked for.
- 9. Students shall not indulge in any activity which may disturb others in the hostel.
- 10. They should ensure parking of cycles/two-wheelers at stands/places earmarked for the same.

### **Anti-Ragging Policy**

Given the directions of the Hon'ble Supreme Court dated 08-05-2009 and the University Grants Commission, the Institute aims to prohibit, prevent, and eliminate the scourge of ragging. We aim to eliminate ragging in all its forms from our Institute, by prohibiting it, preventing its occurrence, and punishing those who indulge in ragging.

#### WHAT IS RAGGING?

Ragging constitutes one or more of any of the following acts:

- 1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating, or handling with rudeness a fresher or any other student.
- 2. Indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- 3. Asking any student to do any act which is not in the ordinary course, and which has the effect of causing or generating a sense of shame, torment, or embarrassment that adversely affects the physical or psychological/mental/general growth of fresher or any other student.
- 4. Any act by a senior student that prevents, disrupts, or disturbs the regular academic activity or any other student or a fresher.
- 5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

- 7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm, or any other danger to health or person.
- 8. Any act or abuse by spoken words, emails, posts, and public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.

#### **OBJECTIVE**

- To Control the Risk of Ragging in AGDC & IGM Hospital.
- To prevent ragging in the AGDC and take proper action against the person who is indulging in it.
- Anti-Ragging Policy Ragging is strictly banned on the premises of AGDC. If anybody is found indulging in such activities, strict action will be taken irrespective of the extent.

To avoid ragging in all forms from the institution by prohibiting and preventing by law following the provisions of the Regulations of Supreme Court, and UGC.

#### STEPS TO BE TAKEN IN AN EVENT OF INCIDENCE OF RAGGING

- 1) Contact number of wardens, all members of anti-ragging committee & squads, relevant authorities have been issued on the notice board. In case of any such occurrence, students may contact any of the above.
- 2) Freshers or any other student, whether being a victim or witness, in any incident of ragging are encouraged to report such occurrence. The identity of such informants will be protected & will not be subject to any adverse consequences.
- 3) Those in a hostel can also contact the hostel warden or any other staff members who will in turn direct the case to relevant authorities.
- 4) Freshers who do not report the incidents of ragging either as victims or as witnesses shall also be punished suitably.





#### **PUNISHMENT FOR RAGGING:**

- a) Penalty for ragging (section 4): Whoever directly or indirectly commits, participates in, abets, or propagates raging within or outside any educational institution shall on conviction be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine that may extend to ten thousand rupees.
- b) Dismissal of the student (section 5): Any student convicted of an offense under section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for five years from the date of order of such dismissal.
- c) Suspension of the student (section 6): Whenever any student or as the case may be a parent or guardian or a teacher of an educational institution complains in writing of ragging to the head of the educational institution, the head of the educational institution must undertake the complaint, within seven and do the inquiry of the matter mentioned in the complaint. If prima facie, it is found true then suspend the student who is accused

- of the offense, and immediately forward the complaint to the police station having jurisdiction over the area in which the educational institution is situated for further action.
- d) Deemed abetment (section 7): If the head of the educational institution fails or neglects to act in the manner specified in section 6 when a complaint of ragging is made, such person shall be deemed to have abetted the offense of ragging and shall on conviction be punished as provided in section 4.

#### ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING


The institution shall punish a student found to be guilty of ragging after the following procedure:

- A) Anti-ragging committee of the institution shall take an appropriate decision following the recommendations of the anti-ragging squad.
- **B)** Anti-ragging committee may depend on the nature and gravity of guilt recommend one or more of the following punishments namely:
  - i. Suspension from attending classes and academic privileges.
  - ii. Withholding or withdrawing scholarship/fellowship & other benefits.
  - iii. Debarring from appearing in tests or examinations.
  - iv. Withholding results.
  - v. Debarring from representing the institution in any regional, national, or international event.
  - vi. Suspension or expulsion from the hostel.
  - vii. Cancellation of admission.
  - viii. Rustication from the institution for a period ranging from 1-4 semesters.
  - ix. Expulsion from an institution and consequent debarring from admission to any other institutions for a specified period.



#### PREVENTION OF RAGGING/ANTI-RAGGING MEASURES:

- 1) Mentor-Mentee system: It should be implemented for 1<sup>st</sup> B.D.S. students with the help of teachers involved in teaching them. About 5-10 students will be allotted to one teacher. They are to meet the concerned teacher every week to discuss various problems faced by students.
- 2) Orientation program: A joint 'Sensitization' and orientation program and counseling for both freshers and seniors will be addressed by the principal and professional counselors. The inmates of the hostel shall be addressed by the hostel warden.
